#### PRINCIPAL'S MESSAGE

The start of Term 3 has seen our students return to the "new normal" of face to face on campus learning. I wish to congratulate all our students and staff for a settled transition into Term 3.

After gaining feedback from staff, students and community, we made the final adjustments to our daily structure that will remain in place for the remainder of 2020. The main changes that have been implemented are as follows:

1. Period structure has changed to a 3-2-1 structure. That is 3 periods in the morning followed by a long break, 2 periods in the middle of the day followed by a short break and 1 period in the afternoon. We have noticed an increase in the engagement of all students during the morning session which is especially pleasing to see.

2. Minimal bells - another change that we have kept since COVID restrictions were put in place is the use of minimal bells. Shoalhaven High School operates now with only 4 bells going throughout the day. These bells signal when the students need to return to class or go home. The effect of using minimal bells has seen calmer and more settled transitions between classes and has also helped the staff keep the students engaged for longer periods of time during lessons. The use of minimal bells has most importantly helped our students develop some more responsibility with regards to time management.

3. Assemblies - due to the AHPPC health guidelines we have decided to place on hold our whole school assemblies for the near future. When this

advice changes we will start to host these events once again.

4. Sport- remains on a Wednesday but has shifted to Periods 4 and 5. Interschool sport can once again recommence and the first sport to "kick off" is Rugby League. The 14's and 16's will begin training at school to participate in the All Schools Challenge during week 7.

5. Uniform - at the end of last term we implemented our uniform policy and require all students to be in full school uniform. The students have responded well and the majority of students now attend in full school uniform each and every day. The image of the school has significantly improved as have the students' engagement levels with school. For students still not in uniform, phone calls home from Year Advisers and Deputy Principals will be made to ensure all students can attend each and every day in uniform. For our Rugby League players, it will be a requirement that you attend school in uniform to be eligible to train and play.

6. Thursday Early Departure (Week A- 5, 7 & 9)-Due to the fact we cannot hold whole school events, we have maintained an early finish, but this has moved to Thursday, Week A. I have been in talks with Transport NSW to negotiate an early pick up for our bus students but at the present time our bus schedule remains the same. To ensure the safety of all students the following procedures have been put in place from next Thursday, 20 August for our early finish:

• All students with local addresses in the East Nowra, Nowra, South Nowra and Worrigee areas will have a personalised early leavers pass with the name and address indicated. At the conclusion of the school day, these students will exit via the school gates and show their cards to the Deputy Principals stationed at the gates. ALL other students will remain inside the school gates and will be supervised by staff rostered on. The library is also available for extra study and catch up work.

• Exceptions to the above: any non-local student who brings a note each early Thursday from a Parent/Carer will be permitted to sign out and be collected by their Parent/Carer. These students show their notes to the Deputy Principals stationed at the exit gates.

Thank you for your ongoing support with these arrangements. These have been put in place to ensure the safety and wellbeing of all our students.


Our Year 12 students will commence their Trial HSC examinations during next week, Week 5. They have been working hard and their results will be a reflection of the effort and attitude they have displayed over the last 2 years. It has been a difficult year for our Year 12 students, with all the restrictions that have been imposed, as well as a period of remote learning. During this time they have all displayed an enormous amount of resilience to persevere with their studies and this will only build on their strong character and ensure they experience success post school. The Trial HSC accounts for 30% of their school assessment and is their final practice of examinations before they commence the HSC in Term 4, 2020. Our Year 12 students completing practical subjects such as Industrial Technology, Visual Art, Music and Society and Culture are also in the process submitting their major marks for HSC marking. These projects take an enormous amount of effort and dedication to complete and I would like to take this opportunity to congratulate both the students and staff on their efforts. We are still preparing and planning for a graduation ceremony and formal, but, the details of these events will be governed by what restrictions are in place regarding COVID-19 and social distancing.

I would also like to invite all parents to our next P & C meeting to be held at Shoalhaven High School. This meeting will take place Thursday, 20 August at 4.40pm in the front meeting of the old Administration Office. All parents are welcome to join the P & C and their input will help shape the direction of Shoalhaven High School in the future.

All the staff at Shoalhaven High School would like to express our ongoing thanks and gratitude to our school community for the support they have shown the school over the past 9 months. We have experienced some very difficult times as a community from fires to floods to COVID-19 to floods and floods again just recently. The support from our community and the value they place on our students' education is a sign that Shoalhaven High School students will always "aim higher" and experience the success of which they are deserving.

#### NATIONALLY CONSISTENT COLLECTION OF DATA

NCCD is an annual collection of data (since 2015) which counts the number of school students with disability and the level of reasonable educational adjustment they are provided. All schools must now collect and submit information annually. Personal details such as student names or other identifying information will not be provided to local or federal education authorities.

#### YEAR 12 HSC TRIAL EXAMINATIONS

The HSC Trial Examinations begin on 17 August 2020 and conclude on 28 August 2020 - Weeks 5 and 6.

Students do not need to remain at school once they have completed an examination - they can sign out and go home. Students who cannot get home will be able to work in the senior areas/ library if available. They need to wear uniform, bring pens and other stationery in a clear bag, and bring water (in clear containers). Phones, smart watches and other devices are not allowed in the examination areas - they can be left with the Deputy Principal or Year Adviser or trusted person.

Students will not be given additional time if they are late for examinations. All students have been issued with a hard copy of their timetables and can also access it via Google Year 12 Wellbeing.

There are no early exits from examinations, unless students are taken ill. If students are absent on the day of an examination, the school should be contacted on 4421 8022 and informed, so Mrs Carson the Year Adviser and Mrs McDonald the Deputy Principal are aware. Students will need to complete a Special Circumstances Appeal form, accompanied by supporting documentation eg a doctor's certificate, to avoid receiving an N Warning letter for missing an assessment task and receiving 0. Mrs McDonald has these appeal forms.



All examinations are part of the assessment schedule for Year 12. Catch up examinations will be held for those who miss exams, as it is vital all outcomes for courses are met.

The HSC Trials are a very important component of Year 12 studies. All students need to be studying at home and in study periods, in order to build opportunities for successful results. The Homework Centre is open on Mondays and Wednesdays to support students, from 3 - 5pm. Good luck to all our Year 12!

#### SCHOOL UNIFORM

Shoalhaven High School has a school uniform that has been endorsed by the schools P & C. It is an expectation that all students present to school in their full school uniform. Students in full school uniform ensure that staff can monitor the safety of all students, and easily identify any persons that are not meant to be on the school site. Research indicates that wearing school uniform helps students build an attachment to the school and can increase engagement in their education.

From Monday 15th June Shoalhaven High School will begin implementing the schools uniform policy. All students have been spoken to about the schools' expectations and the procedures that will be commencing from Monday. Each day students will be marked regarding their uniform during daily lessons as staff members mark the roll. This information will be collated by Ms Wood (HT Wellbeing).

The monitoring process and consequences are outlined below:

- 1. Students out of uniform will be recorded each lesson by the staff member.
- 2. A tally is collated on a 2 week cycle.
- Each time a student hits a threshold of six (6) times out of uniform they are placed on the uniform list.
- 4. When a student has been marked out of uniform twelve (12) times the Year Adviser will make contact with students and family to offer support or assistance in acquiring uniform.
- 5. When a student is marked out of uniform eighteen (18) times the Deputy Principal will make contact with the students and families and the issue will be considered as defiance. Further non-wearing of school uniform will result in students being asked to go home and change or be placed in the Reflection Room for the day for persistent defiance and complete their studies.

Acceptable uniform can include: navy jumpers (with no logos), navy tracksuit pants and undershirts that Respect, Responsibility, Safety & Participation are the same colour as our school uniform (white or navy blue).

If a student is out of uniform and has a note to explain the reasons why, they present the note to their roll call teacher who will sign the note and return to the student. Students are then required to present the note to their class teachers and will **NOT** be marked out of uniform for that day.

If any financial assistance is required with uniform please do not hesitate to contact the school and speak with the Principal, Deputy Principal or Year Adviser so arrangements can be made. Families on eligible pension and health care cards are entitled to a one off \$80 payment to spend on uniform through our uniform shop. The uniform shop is located on site and is open Mondays and Thursdays from 9:00am-1:00pm

We thank you for your support in ensuring all our students attend each day in full school uniform.



#### **YEAR 9 VISUAL ARTS**



# SCHOOL BUS SAFETY

Behaviour on the Bus:

• Remain seated at all times (where seat available) and don't swing on hand rails

• Don't throw things around the bus or touch other student's property

- Don't stand in doorways or the bendy section of the bus when moving
- Follow instructions given by the bus drivers
- Be considerate of other students and don't threaten or intimidate others

• Don't use offensive language or distract the driver unnecessarily

Departing Bus:

- Don't get up from your seat until you need to and hold on to the rail when standing
- Don't walk out from behind or in front of the bus as vehicles
- Wait until the bus leaves and you have a clear view in both directions before crossing the road

• If a parent is waiting for the bus, please wait on the correct side of the road so your child doesn't need to cross the road to meet you





# NSW Health is ensuring that students are safely vaccinated at school during COVID-19

- Information for parents/guardians

NSW Health has been working with education authorities to implement additional measures to ensure that students in Year 7 and 10 can be safely vaccinated during the COVID-19 pandemic.

# **Program background**

In 2020 NSW Health is offering the following vaccines:

YEAR	VACCINE	NUMBER OF DOSES
Year 7	Human papillomavirus (HPV)	2 doses at least 6 months apart
	Diphtheria, Tetanus and Pertussis (dTpa)	1 dose
Year 10	Meningococcal ACWY	1 dose

While the school vaccination program has been disrupted due to low student attendance, students are progressively returning to school over the coming months.

#### Additional measures

NSW Health has implemented additional measures based on expert clinical advice to reduce the likelihood of COVID-19 transmission in school clinics, including:

- health screening of nurses before clinics
- pre-vaccination screening of students
- physical distancing restrictions at the clinic entrance & observation area
- ensuring the number of students and nurses at the clinic does not exceed the maximum allowed
- enhanced hand hygiene by nurses and students
- enhanced environmental cleaning of all surfaces

#### What parents/guardians should do

Parents/guardians should ensure that students with influenza-like symptoms do not attend school and are tested as soon as possible (<u>www.nsw.gov.au/covid-19/symptoms-and-testing</u>). There is no need for parents/guardians who have given consent for their child to receive vaccinations at school to take any action. Parents/guardians who have not provided consent can contact their local public health unit on 1300 066 055 or their school for advice on how to provide consent for vaccination.

#### When students will be vaccinated

Public health units are arranging clinics with schools so that vaccinations can be given to students as soon as possible.

# **Compulsory School Attendance**

Information for parents

Education for your child is important and regular attendance at school is essential for your child to achieve their educational best and increase their career and life options. NSW public schools work in partnership with parents to encourage and support regular attendance of children and young people. When your child attends school every day, learning becomes easier and your child will build and maintain friendships with other children.

#### What are my legal responsibilities? What if my child has to be away from

Education in New South Wales is compulsory for all children between the ages of six years and below the minimum school leaving age. The Education Act 1990 requires that parents ensure their children of compulsory school age are enrolled at, and regularly attend school, or, are registered with the Board of Studies, Teaching and Educational Standards for homeschooling.

Once enrolled, children are required to attend school each day it is open for students.

#### The importance of arriving on time

Arriving at school and class on time

- ensures that students do not miss out on important learning activities scheduled early in the day
- helps students learn the importance of punctuality and routine
- gives students time to greet their friends before class
- reduces classroom disruption.

Lateness is recorded as a partial absence and must be explained by parents.

# school?

On occasion, your child may need to be absent from school. Justified reasons for student absences may include

- being sick, or having an infectious disease
- having an unavoidable medical appointment
- being required to attend a recognised religious holiday
- exceptional or urgent family circumstance e.g. attending a funeral.

Following an absence from school you must ensure that within 7 days you provide your child's school with a verbal or written explanation for the absence. However, if the school has not received an explanation from you within 2 days, the school may contact you to discuss the absence.

Principals may decline to accept an explanation that you have provided if they do not believe the absence is in the best interest of your child. In these circumstances your child's absence would be recorded as unjustified. When this happens the principal will discuss their decision with you and the reasons why.

Principals may request medical certificates or other documentation when frequent or long term absences are explained as being due to illness. Principals may also seek parental permission to speak with medical specialists to obtain information to collaboratively develop a health care plan to support your child. If the request is denied, the principal can record the absences as unjustified.

#### Travel

Families are encouraged to travel during school holidays. If travel during school term is necessary, discuss this with your child's school principal. An Application for Extended Leave may need to be completed. Absences relating to travel will be marked as leave on the roll and therefore contribute to your child's total absences for the year.

In some circumstances students may be eligible to enrol in distance education for travel periods over 50 school days. This should be discussed with your child's school principal.

#### My child won't go to school. What should I do?

You should contact the principal as soon as possible to discuss the issue and ask for help. Strategies to help improve attendance may include a referral to the school's learning and support team or linking your child with appropriate support networks. The principal may seek further support from the Home School Liaison Program to develop an Attendance Improvement Plan.

# What might happen if my child continues to have unacceptable absences?

It is important to understand that the Department of Education and may be required to take further action where children of compulsory school age have recurring numbers of unexplained or unjustified absences from school.

Some of the following actions may be undertaken:

Compulsory Schooling Conferences

You may be asked, along with your child, to attend a Compulsory Schooling Conference. The conference will help to identify the supports your child may need to have in place so they attend school regularly. The school, parents and agencies will work together to develop an agreed plan (known as Undertakings) to support your child's attendance at school.

Application to the Children's Court

 Compulsory Schooling Order

If your child's attendance at school remains unsatisfactory the Department may apply to the Children's Court for a *Compulsory Schooling Order*.

NSW DEPARTMENT OF EDUCATION

The Children's Court magistrate may order a Compulsory Schooling Conference to be convened.

• Prosecution in the Local Court

School and Department staff remain committed to working in partnership with you to address the issues which are preventing your child's full participation at school. In circumstances where a breach of compulsory schooling orders occurs further action may be taken against a parent in the Local Court. The result of court action can be the imposition of a community service order or a fine.

# What age can my child leave school?

All New South Wales students must complete Year 10 or its equivalent. After Year 10, and up until they reach 17 years of age, there are a range of flexible options for students to complete their schooling.

#### Working in Partnership

The Department of Education recognises that working collaboratively with students and their families is the best way to support the regular attendance of students at school.

We look forward to working in partnership with you to support your child to fulfil their life opportunities.

LEARNING AND ENGAGEMENT

If a student misses as little as 8 days in a school term, by the end of primary school they'll have missed over a year of school.


